# JOHOR PORT PRIORITISES IN MAINTAINING THE HIGHEST LEVEL OF SAFETY AND SECURITY THROUGH COMPETENCY ENHANCEMENT PROGRAMME FOR ITS AUXILIARY POLICE FORCE

**JOHOR BAHRU, 21 April 2021 -** As the Southern Gateway Multi-Purpose Port in Malaysia that contributes not only largely to the nation but also global trade, Johor Port Berhad (Johor Port), a member of MMC Group, prioritises in maintaining a safe and secure environment for its port users and customers to conduct business.

At Johor Port, its armed security force known as the Johor Port Auxiliary Police is responsible to ensure utmost protection from any potential threats whether by land, sea or air. They provide patrolling and 24-hour surveillance at all entry and exit points to various facilities within the port as well as enforcing both port and maritime safety regulations at Johor Port's waterfront.

The Johor Port Auxiliary Police force comprises of a team of 85 officers and members of which five (5) of them are women. The Johor Port Auxiliary Police officers and members are authorised to carry firearms as they are the primary responders for all reported crimes and incidents within its jurisdiction.

On top of the Auxiliary Police Training at the Police Training Centres (PULAPOL), the armed security force also undergoes various skills trainings regularly to strengthen its performance and ensure adequate preparation for various services and security roles such as Marine Facility Security Officer for vessel searches.

Johor Port recently conducted the 2021 Bi-Annual Firearms Training for its Auxiliary Police at the Kota Tinggi REM Farm Shooting Range on 1, 3 and 9 April 2021. The Firearms Training aimed at enhancing the usage of firearms through up-to-date



training and improving the level of preparedness when encountering any situation involving firearms usage.

The training programme consisted of a briefing session and practical training on the procedures and safety aspects of handling firearms, followed by 'Centre Fire' gun and 'Falling Plate' pump-action gun skills training sessions. The weapons used during the training consisted of Glock19 9mm gun type firearms and 12-bore pump guns. The training session ended with a swearing-in ceremony by all the participants. The next firearms training will be conducted in October 2021.

"In any maritime operations, the number one priority is to ensure utmost port security - this is because the marine transportation sector is a thriving and extensively used form of conveyance that contributes largely to the nation's economy. Here at Johor Port, we ensure regular training is conducted for all police officers to help provide adequate foundation in carrying out important safety-related tasks," explained Md Derick Basir, Chief Executive Officer of Johor Port.

The Johor Port Auxiliary Police also collaborates with multiple Government entities such as Royal Malaysian Police (PDRM), Customs, Immigration, National Anti-Drugs Agency (AADK) and other Government Agencies such as the Malaysian Quarantine and Inspection Services (Maqis) Department to facilitate in monitoring and providing safety and security spanning miles of waterfront and land-based facilities.

Ports are the main gateway of a country and an important sector in generating the growth of the national economy. Due to this, the aspect of security at ports should not be taken lightly.

In line with the need to ensure adequate and comprehensive security at ports, the Port Security Force was established as provided under the Port Authorities Act 1963 and this security force was further strengthened by granting police powers to each officer and member who has been appointed as an Auxiliary Police as provided under the Police Act 1967.

This is also in line with the requirements of the *Arahan Tetap Sasaran Penting 1990,* a national safety and security guideline, where the ports are regarded as a primary source of the nation's economy and to a certain extent, plays a vital role in the functioning of the Government and contributing to the overall image of the nation - hence, it requires the supervision and monitoring of armed security forces. This Security Force is also known as the Port Auxiliary Police.
