PENANG PORT ADDS ANOTHER HISTORIC MILESTONE

PENANG, 8 February 2020 – The 1st of February 2021 will forever be etched in the history books as North Butterworth Container Terminal (NBCT) was gazetted as a free commercial zone (FCZ). Another historic milestone, Penang Port Sdn Bhd (Penang Port) is set to be a focal point for shipping and transhipment activities.

Penang Port is one of the oldest and established port in Malaysia and serves as the primary gateway to the Northern region of Malaysia and Southern Thailand, serving the basins of the Straits of Malacca and the Gulf of Bengal.

One of the main terminals of Penang Port is the North Butterworth Container Terminal (NBCT). The container operation is the core service for Penang Port. Penang Port's connection with containers dated back to 1974, with the first container discharged at Butterworth Wharves.

2010 was a significant year for Penang Port as it achieved one million Twenty-foot Equivalent Unit (TEUs). This achievement was an astounding leap from 1973, where it started from 516 TEUs. As of 2021, Penang Port has grown steadily to achieve a throughput of more than 1.5 million TEUs.

Before the NBCT T1 project, the total berth capacity was at 2.1 million TEUs. Upon completion of the T1 project, the overall capacity increased to 2.3 million TEUs. The increase of 200,000 TEUs will oversee the surge of berth utilisation and reduce the vessel waiting time to berth.

The process of obtaining the FCZ status was an uphill task for Penang Port. Since 2007, Penang Port has started the initiative to gazette NBCT as FCZ. It was only in 2018 when Penang Port Commission (PPC) and Penang Port finally revisited the plan to gazette the entire NBCT by requesting approval and support from Penang State



Economic Planning Unit. The gazettement of NBCT involves ten (10) lots of land covering the total area of 83.57 hectares.

One of the most impactful activity after the gazettement of NBCT as FCZ will be transhipment. Transhipment is the shipment of goods or containers to an intermediate destination before being taken to another destination.

Penang Port will capitalise on the newly found status to tap into the Bay of Bengal market by undertaking transhipment activities for containers moving between the Bay of Bengal and the Far-East. In the near future, Penang Port's plan is to link-up feeder operators in Bay of Bengal with mainline operators.

The FCZ will attract more traffic to NBCT and this will increase job opportunities which are very much needed during the COVID-19 pandemic.

Apart from job opportunities, the port could leverage on the FCZ status to entice investors around the world to conduct value-added activities such as break-bulking, grading, repackaging, relabeling, transit and re-export.

With the establishment of FCZ in NBCT, foreign companies will be able to use the facilities before exporting their product overseas. This will also benefit Penang Port in the long run through the exempt customs' duty, excise duty, sales tax and service tax except for certain goods. The local workforce and port operations will be much more efficient once the facilities are upgraded; cutting-edge technologies are implemented and introduced to cater to the foreign investors.

The FCZ operations will commence on March 2021 and this will put Penang on the world map as NBCT will be able to cater activities such as high-tech warehousing and logistics facilities thus spearheading the positive economic growth in the Northern region of Malaysia.
